➤ From WCC to ENSMOV

Every 2 years since 2011, ATEE has organised in Paris a European meeting to share good practices on Energy Efficiency Obligations, which has been labelled WCC (White Certificates Club) meeting, the last one being held in June 2017.

Since the WCC meetings are right in the intention of the new ENSMOV project, the WCC 2019 edition will be fully incorporated in the launching of ENSMOV (<http://ensmov.eu/>), ATEE being one of the 15 partners of this project.

➤ More on ENSMOV

The ENSMOV project, which is a H2020 project and somewhat a continuation of former ENSPOL project, is dedicated to enhancing the implementation and monitoring and verification practices of Energy Saving Policies under article 7 of the Energy Efficiency Directive (EED).

During the 3 years of the project, from 2019 to 2022, the ENSMOV project will address 10 key points relative to policy design and MRV (Measurement, Reporting, Verification) practices, through 3 cycles of one year of exchange and debate between the various stakeholders of these energy policies. The ENSMOV partners coming from 14 EU countries, the exchanges will be focussed on these countries but could go beyond.

The 11th December will be the day ENSMOV will launch the first cycle of exchanges between the stakeholders of EED Article 7.

In the morning, it will look like a usual WCC meeting, with a focus on Energy Efficiency Obligations, and the afternoon will be dedicated to alternative measures.

At lunchtime, we will hold presentations, discuss the issues which will be debated during the course of the project, and we will offer all participants to register for those issues that are of interest to them, in order to be informed and to be able to participate in ENSMOV future exchanges.
